SUBMISSION OF THE ANNUAL REPORT FOR THE COMMERCIAL COURT DIVISION FOR THE YEAR ENDING 31 DECEMBER 2013

I have the honor and privilege to submit to you the Annual Report for the Commercial Court Division for the year ending 31 December 2013.

The report sets out the Division's performance, activities, achievements and challenges for the year under review. The year review shows significant increase in cases filed at the time. The Division however, did its best to rise up to the challenge and handle the cases as they came. Performance of the division at a glance is summarized in the executive summary of the report

2.0: EXECUTIVE SUMMARY

This is the 18th year that the Commercial Court division of the High Court has been in operation on the African Continent.

At creation, it was intended and mandated with the task of delivering an effective, expeditious and cost effective way of adjudicating disputes to the commercial community.

The last year has been yet another successful year for us. Our vision continues to be

"the leading provider of commercial dispute resolution services and products in the region consistent with the best practices worldwide."

It is through the foregoing that we fulfill our mission that demands of us.

To deliver judicial services to the Commercial community of Uganda by providing:

"A Commercial Court which is accessible to all businesses and which processes commercial suits expeditiously and justly."

Ultimately, the goal is to ensure that the business Community can participate on equal legal footing characterized by quick case disposal.

The footing of equality and quick disposal has become more secure over time, and the court has made significant strides in enhancing professionalism through improved interaction with the Commercial bar and ensured that best practices are upheld by the stakeholders at the Division.

However, just like any activity, this relationship requires a firm grasp of the emerging best practices to ensure continued existence of an environment conducive to fast dispute resolution.

The Division continues to attract Judges, Justices and administrators of other Judiciaries on the continent as a learning centre.

In the year 2013, the Court hosted a delegation of Justices from the Commercial Court of Liberia who were enlightened with what they saw.

We cannot talk about this past year without mentioning the Division's performance.

In the year 2013, 2417 matters were filed which constituted 22.6% more than the previous year. The total number of cases disposed off was 1,747. I must say that notwithstanding, the increased filings, the backlog in the Division still like the previous year stood at 13%. This is not to say that 13% is good at all.

The increased case disposal in my view was due to the backlog sessions held last year and the increased number of Judges after the midyear court recess who were posted at the Division.

Because of the increase in case filing at the Division, the workload in the Mediation Registry also increased by 15.8%. There was a noticeable reduction of 3.3% of case disposal through mediation compared to 2012.

Amidst the foregoing accomplishments, there is still a lot of work to be done. Building and sustaining a quality and quick dispute resolution court requires commitment by both the bar and the bench. The two must prepare for the court sessions. It was realized that in 2013 many members of the bar came to court without adequate preparation. It is also important to minimize adjournments. Adjournments in 2013 stood on average at 3.4 compared to 2.8 in 2012. It is our resolution at Commercial Court Division to reduce on adjournments as much as possible.

There is need for continued training of the adjudicating group especially in the new cyber world, taxation, Oil and Gas disputes. Hardly a day passes without a case emerging from these fields.


Since knowledge is the bedrock of effective dispute resolution, training stands out as one of the 2014 priorities.

We face 2014 energized by our successes in 2013.


3.0: THE PERSONNEL OF THE COURT AS OF 31ST DECEMBER 2013





4.0: MEDIATION



5.0: WORKLOAD OF THE DIVISION

The workload at the Division is the sum of the cases brought forward from the previous year and those that are filed as the year moves on. In the year 2013, the workload increased by

21.4% in comparison with the previous year and this trend is attributed to increased filing.

FILINGS IN 2013


The Division received a total of 2417 suits which constituted 22.6% increment compared to the previous year. Furthermore, the cases brought forward from 2012 led to an increased overall workload of 4,165 cases.

The steady increment in filed matters was most probably inspired by unstable economic conditions that must have led to increased failure of the Commercial Community meeting their obligations and also due to increased confidence in the Division's judicial effectiveness.



WORKLOAD PER JUDICIAL OFFICER

The division's average workload per Judicial Officer reduced to 378.6 from 556.3 matters in all case categories.

This reduction is attributed to the increased number of judicial officers at the Division.

DISPOSAL OF MATTERS BEFORE COURT

The Commercial Court overall disposal rate at the end of 2013 stood at 41.9%. However the disposal rate of matters filed without cases brought forward from 2012 was at 44.64%. This disposal rate could have been better, but because some of the Judges who were transferred to this Division had to write Rulings and Judgments of

matters from their previous stations. There was also the usual slow in business which takes place when settling in a new station. Furthermore, part of the time in the second half of the year both July and December falls in the recess period which affects civil courts.



6.0: CASE BACKLOG BASED ONLY ON CIVIL SUITS FILED

The Division case backlog is defined as cases that have remained in the Court for a period of two years and more, from the time of filing without being disposed of. In the year 2013 the division held a backlog session which helped to maintain a 13% case backlog


as the previous year despite more cases brought forward from 2012.

7.0: MEDIATION PERFORMANCE

The Mediation Registry in the year 2013 had an overall workload of 623 constituting 468 filed cases in the same year and 155 cases brought forward from 2012. 383 cases were

disposed of showing a reduction in the disposal rate of 60.7% as compared to 73.1% of the previous year. The reduction in the disposal of cases is attributed to the fewer number of the accredited mediators.

However, the training which was scheduled for 9th December, 2013 in Mediation practice as a process of


10.0: INFORMATION AND COMPUTER TECHNOLOGY (ICT) OF THE DIVISION


In the bid to modernize and promote faster information exchange among the Court stakeholders, the ICT Division installed an electronic Notice-board that has positively impacted on the information dissemination from the Court to its users, through display of Cause-list and News feeds in the announcement strip. Furthermore, with an already existing Commercial Court Mailing-list (causelist.cc@gmail.com), the Court has streamlined information exchange through which the weekly cause-list and any other important information is sent to the Court users.

rolling out mediation to the entire Judiciary was rescheduled to 10th March, 2014. We hope that the Judiciary Administration will as usual avail the necessary financial support.

The Division has fully adopted Court room Technology among other ICT innovations i.e. the Digital Court Recording and transcription in all the Court Rooms.

The Division together with the Judiciary hopes for a speedy adoption of more ICT innovations which include; E-filing, Courtroom Video conferencing, and Tele-conferencing, Mobile Evidence Presentation System and display devices among others. Justice Henry Peter Adonyo.





13.0: CHALLENGES

The Division continues to face challenges with limited financing, which has subsequently impacted negatively on the Court activities and developments.

The Mediation Registry ran most of 2013 without a Registrar and this posed a lot of challenges and a heavy workload for the already existing judicial staff.

Another challenge that continues to face the Division is the absence of Judge Assistants or Researchers. The presence of such assistants would ease the research burden of Judges and improve on their output.

The Server room Air Conditioner for ICT Servers frequently breaks down because of the heavy workload, posing a threat to the servers which at

anytime could crash because of the excessive heat. It's therefore prudent that a heavy duty Air Conditioner be installed in the server room to ensure that operation in the division is uninterrupted.

Another challenge that the division is facing is lack of enough process servers and office attendants who are meant to support the work of the judicial officers

14.0: CONCLUSION AND WAY FORWARD

The increase in the judicial personnel in the division, we hope will help curb the rising backlog that has been increasing by 13% for the previous two years.

The Commercial Court also hopes a Mediation Registrar will be assigned as soon as possible to mitigate increasing workload in the Mediation Registry.
