1. The Judiciary has allocated/received fund from Government of Uganda to be used for the Construction of Appellate Court Houses.
2. The Judiciary invites sealed bids from eligible bidders for the provision of construction of the above Houses.
3. Bidding will be conducted in accordance with the open domestic bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders from Uganda and international Bidders.
4. Interested eligible bidders may obtain further information from the Judiciary and inspect the bidding documents at the address given below at 7(a) from 8:00 am to 5:00pm.
5. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address below at 7(a) and upon payment of a non-refundable fee of **shs.200,000/=(Two hundred thousand)**. The method of payment will be BPAF. The document will be picked from the High court building, Kampala. There shall be a **Pre-Bid Meeting at the High Court Building, Kampala** on the dates and venue indicated in the proposed schedule in this notice.
6. Bids must be delivered to the address below at 7(a) at or before 11:00Am on **30<sup>th</sup> September, 2019**. All bids must be accompanied by a bid security of Ugx. **1,000,000,000 (One Billion Uganda Shillings)**. All Bid Securities must be valid until **24<sup>th</sup> February, 2020**. Late bids shall be rejected. Bids will be opened in the

presence of the bidders' representatives who choose to attend at the address below at 7(a) at **11:30am East African Time on 30<sup>th</sup> September, 2019.**
