# PERFORMANCE OF THE LAND DIVISION AND EMERGING TRENDS IN THE LAND JUSTICE SYSTEM.

# 1. INTRODUCTION

The High court Land Division(herein after "the land division") as indicated during the last judges conference remains committed to timely delivery of quality justice, within the available resources and unlike last year ,the Land division is now run by 6 judges . All these judges are new in the division and have done commendable work since their deployment.

It is worth noting that, Hon. Justice Owiny Dollo of the international crimes and Execution continues to actively dispense Land Justice in this division. This increased number of Judges, which has helped a lot to reduce backlog of cases in the Division.

Not only was the number of judges increased, but the support staff was also beefed up and this has helped in the improvement of service delivery at this division.

We thank the administration for these developments, because this has helped the division to address some of the pressing challenges the division had.

There was a physical count of files and update in order to enable the Judges to handle files that have over stayed. This enabled us to remove all the files that had been redundant over years and we disposed of those that had been over taken by events. This has tremendously reduced on the backlog.

#### 3. CASE STATUS

As at the end of December 2013, we had a case load of **5317** assorted cases, as per Table 2 below:

New case registration has steadily increased over the years, with 1563 cases registered in 2010, 1638 in 2011, 1996 in 2012, and 2140 in 2013.

#### 4. Challenges

- There is need for more Research Assistants because there are only 3 and yet the Judges are 6.
- The work load in the division is too much for one Registrar.
- There is still need for a motor cycle or two for the process servers.
- Twed Towers is out of town, necessitating a van for support staff.
- Twed Towers has other constraints, including incessant and rather embarrassing power cuts, threatened water dis-connections.
- The premises are both unsuitable and in adequate, we have no space for a library, court rooms and stores of exhibits and other items that need secure storage.

#### 5. Way forward

- We intend to pursue sessions further in accordance with our already submitted work plan, targeting at least 840 Cases. This shall however require assistance from the Administration, by provision of funds and personnel.
- The Division should have one Deputy Registrar and 2 Assistant Registrars with one specifically for mediation.
- We intend to also carry out a comprehensive weed out exercise targeting especially miscellaneous applications.
- The planned mediation committees reflected in our last year report are yet to be functional we intend with the assistance of the administration to peruse mediation more aggressively.
- The division needs special training for the Judges and Registrars in ADR approach. This is urgent.

#### Conclusion

Land is a very vital asset, and due to population pressure, land has become even more valuable, with conflicts becoming ever rampant and serious. This makes Land Justice a critical area that may reflect favorably upon the Judiciary as a whole.

The land division takes this opportunity to thank everyone for the support rendered during the year 2013 and wish you a fruitful 2014.

In particular we would like to thank the Uganda Land Alliance for providing facilitation for the Land User Committee meetings during the year 2013. In the same vein we would like to thank U.L.S for parternering with us and always publishing our cause lists and day to day co-operation.

Equally we thank all the stake holders for their invaluable concern in the affairs of Land matters in the Division. Last but not least, as the Head of Division, I thank all the Honorable Judges of the Division and in particular predecessors in the Land Division for setting the pace.
