# GUIDELINES ON EXECUTION OF COURT JUDGEMENTS, ORDERS AND DECREES DURING THE PREVALENCE OF COVID-19

CONSIDERING the various petitions, complaints and concerns filed in my office regarding the stay of execution during the Covid -19 lockdowns;

AWARE OF the need for litigants to realize fruits of their judgement after a long and costly protracted hearing phase;

IN REFERENCE TO the Guidelines to mitigate the spread of Covid- 19 I issued on 29<sup>th</sup> January, 7<sup>th</sup> of June, 21<sup>st</sup> June 2021 and 2<sup>nd</sup> August 2021;

IN ORDER TO balance the interests of justice of all the persons who have sought justice in the Courts;

IN LINE WITH the Presidential Statement to the Nation on the Progress of the Covid-19 Response issued on 22<sup>nd</sup> September 2021 which further eased the lockdown and opened up more sectors; and

PURSUANT TO the powers conferred upon the Chief Justice by Article 133 of the Constitution;

I HEREBY ISSUE these Guidelines on Execution of Court Judgments, Orders and Decrees with effect from the 11th of October, 2021.

#### A: Execution Process

- 1. All Courts are hereby directed to receive and process applications for execution in accordance with the relevant laws and practices.
- 2. Registrars and Magistrates are specially cautioned to ensure the authenticity of the Court Judgments, orders and decrees before they process them for execution.
- 3. Where there are several modes of execution available in a particular case, the Warrant of Arrest of a judgement debtor for committal to civil prison should only be issued as a last resort.

- 4. Every Court Bailiff must present a valid Licence to Court before being issued with a Warrant of Execution.
- 5. In all matters requiring eviction, demolition and/or giving vacant possession, the Constitution (Land Eviction) (Practice) Directions, 2021, (Legal Notice No. 2 of 2021) must be adhered to.
- 6. Applications for Distress for Rent Orders must be made strictly in accordance with the relevant law and before a Court that has both the geographical and pecuniary jurisdiction to determine the matter.
- 7. All execution proceedings in Court and out of Court must be carried out with due observance of the Covid-19 Preventive Measures issued from time to time by the Chief Justice and the Ministry of Health.

### B: Modification of earlier Guidelines

- 8. These Guidelines are in addition to the other Guidelines previously issued, which remain in force, subject to the specific modifications provided for herein.
- 9. These Guidelines may be amended from time to time.
