The Plaintiffs and others filed High Court Civil Suit No. 719 of 1997 in the High Court at Kampala against the Attorney General claiming money for recovery of their value of motor vehicles which were unlawfully illegally impounded by soldiers of the Uganda Peoples Defence Forces (UPDF) and special damages constituting loss of earning and for costs of the suit, On 2nd September, 2005, a consent judgment in HCCS No. 719 of 1997 was entered in favor of the Plaintiffs and which was confirmed by ruling on interpleader pleadings in Misc No. 361 of 2015. On 16th September 2019 a variation consent was entered btn the plaintiff and others with the Attorney General and it was confirmed that the plaintiffs with a one Janvier Busogi were entitled to a Government Compensation for the sum of ugx 6,062,949,441. The Plaintiffs changed their instructions from M/s Sekabanja & co Advocates to M/s Twikirize & Co. Advocates in order to receive their compensation which was notified to Ministry Finance , Planning and Economic Development and the Solicitor General. 2. The Defendant later transferred to M/s Twikirize & Co. Advocates the new lawyers a sum of 590,000,000/= on 2nd December 2020. The Defendant subsequently halted payments through M/s Twikirize & Co Advocates and insteady paid the plaintiffs the sum of 710,000,000/= leaving a balance of 2,450,399,419/=. after deducting the defendant's legal fees and valuation fees due M/s Kavuma & Associates. 3.
