The Plaintiffs changed their instructions from M/s Sekabanja & co Advocates to M/s Twikirize & Co. Advocates in order to receive their compensation which was notified to Ministry Finance, Planning and Economic Development and the Solicitor General.</p> <p>2. The Defendant later transferred to M/s Twikirize & Co. Advocates the new lawyers a sum of 590,000,000/= in two tranches ie 240,000,000/= on 14th October 2020 and 350,000,000/= on 2nd December 2020. The Defendant subsequently halted payments through M/s Twikirize & Co Advocates and instead paid the plaintiffs the sum of 710,000,000/= leaving a balance of 2,450,399,419/= after deducting the defendant's legal fees and valuation fees due M/s Kavuma & Associates.</p> <p>3.
