#### MANDATE OF THE HIGH COURT

- a) The High Court is created under Articles 138 140 of the Constitution of Uganda
- b) It is the third Court of Record in the order of hierarchy and has unlimited original and appellate jurisdiction
- c) Appeals from Chief Magistrates Courts, Magistrate Grade I Courts and some Administrative Tribunals go to the High Court
- d) The Court also has supervisory powers over Magistrates' courts and Local Council Courts through appeal and revisionary jurisdiction.



#### **COMPOSITION OF THE HIGH COURT**

The High Court has been decentralized into Divisions and Circuits

- a) There are seven Divisions namely: (1)Civil, (2)Commercial, (3)Family, (4)Land, (5)Anti-Corruption, (6)International Crimes and (7)Criminal
- a) The Judiciary currently has 38 High Court Circuits. 24 High Court Circuits are operational. That is (1) Arua, (2) Bushenyi, (3) Fort portal, (4)Gulu, (5)Hoima, (6)Iganga, (7) Jinja, (8) Kabale, (9) Kasese, (10)Kiboga, (11) Kitgum, (12) Lira, (13)Luwero, (14)Masaka, (15) Masindi, (16) Mbale, (17)Mbarara, (18)Moroto, (19) Mpigi, (20)Mubende, (21) Mukono, (22) Rukungiri, (23) Soroti and (24) Tororo.


The none operational circuits are, Apac, Bugiri, Dokolo, Entebbe, Ibanda, Kumi, Lugazi, Moyo, Nebbi, Ntungamo, Pallisa, Patongo, Rakai and Wakiso. All these were recently gazzated in November 2023.

# OVERALL PERFORMANCE OF THE HIGH COURT ( DIVISIONS AND CIRCUITS) FOR THE LAST THREE (3) YEARS

- a) The High Court has recorded tremendous growth in case disposal and case registration over the last three (3) calendar years-2021,2022 and 2023.
- b) 3-year highs of **41,216** cases completed and **49,788** cases registered were recorded in the year 2023




# DISPOSAL RATES AND CLEARANCE RATES OF THE HIGH COURT (DIVISIONS AND CIRCUITS) FOR THE LAST THREE (3) YEARS -cont'd

- a) The High Court recorded a steady rise in disposal rates and a general improvement in clearance rates over the 3-year period.
- b) A 3-year high of 39.17 % disposal rate and clearance rate of 82.78 % were realized in the year 2023.
- c) This points to an overall improvement in efficiency in the disposal of cases over the last 3 years.

# PERFORMANCE OF THE HIGH COURT ( DIVISIONS AND CIRCUITS) IN CASES OF A CIVIL NATURE

- a) The High Court has recorded tremendous growth in the disposal and registration of cases that are Civil in Nature (Civil, Commercial, Family and Land) over the last three (3) calendar years-2021,2022 and 2023.
- b) 3-year highs of **33,364** cases completed and **39,277** cases registered were recorded in the year 2023.
- c) The High Court recorded a 3-year low of 48,933 pending cases.

### Possible casuses of this underperformance

- wrong statistics (Discripancy between what we get in qurtery review meetings and the statistic received from Magistrates affairs)
- Insufficient Judicial officers
- Failure to write Judgements when due (By December 1,623 Judgements Pending, 15 judges with more than 60 judgements pending)
- Underperformance of some Judicial officers (Analysis almost complete on underperformance)
- Jurisidiction issues (Magistrates almost redundant on land matters)-Solution being found.

# PERFORMANCE OF THE HIGH COURT ( DIVISIONS AND CIRCUITS) IN CASES OF A CRIMINAL NATURE

- a) The High Court has recorded tremendous growth in case registration of cases that are Criminal in Nature (Anti-Corruption, Criminal and International Crimes) over the last three (3) calendar years-2021,2022 and 2023.
- b) There was a 548-cases decline in cases disposed of a Criminal Nature in the year 2023 as compared to the year 2022.
- c) This decline arose from a reduction in the number of Criminal and Anti-Corruption Cases completed.
- a) The High Court recorded a 3 –year high of 10,511 Cases registered cases ( of a Criminal Nature in the year 2023.

### Posible Causes of this underperformance

- Failure to enter finished criminal session results in CASS especially those out of station.
- Introduction of daily hearings (Analysis still being made)
- Plea bargaining results not entered in the system after completion of sessions
- Insufficient session funds
- Competing demands of civil and criminal sessions



#### PERFORMANCE OF THE HIGH COURT DIVISIONS FOR THE YEAR 2023

- a) The Land Division recorded the highest disposal (8,018 cases) and registration (8,367 cases) in the year 2023.
- b) This was followed by Commercial Division (disposal-5,322 cases, registration-7,264 cases).
- c) Despite International Crimes Division posting the lowest case disposal figures for the year 2023, the 92 cases disposed of represents a 3-year high for the Division.

# OVERALL PERFORMANCE OF THE HIGH COURT CIRCUITS FOR THE YEAR 2023

- a) The Highest disposal and Registration was recorded in Criminal Cases (Disposal-6,316 cases, registration -8,577 cases )
- b) This was followed by Civil Cases (Disposal- 6,417 cases, registration 8,720 cases )
- a) The lowest disposal and Registration was recorded in Commercial Cases ( Disposal- 14 cases, registration -51 cases )

## HIGH COURT QUARTERLY PERFORMANCE REVIEW MEETINGS

I hold High Court Quarterly Performance Review meetings with Heads of Divisions and circuits in conjunction with the case backlog committee chaired by the Hon. the Deputy Chief Justice.

The High Court Quarterly performance review meetings have been held for three years now. Our next meeting is scheduled on 22-23, February, 2024. The deadline for submission of performance reports is today.

We have come up with several recommendations intended to improve performance of the High Court and its subordinate courts in order to serve our people better.

Key among the recommendations are;

REPORTING. Timely reporting of statistics signed by the Judges, covering areas of under performance and reasons for underperformance.

- Supervision and regular inspection of Magistrates Courts.
- Delivery of quality decisions.
- ❖ Judges in circuits to take keen interest in supervising construction projects in the circuits to ensure standardization of construction of court buildings across the country.
- Benchmarking and implementing good practices from other courts.
- Ensuring effective case management by carring out regular weeding out exercises, regular update of CCAS system, hearings and delivery of rulings, encouraging ADR etc.
- Timely disbursement of funds for sessions and locus visits, timely use of the same and ensuring timely submission of accountabilities.
- Creativity and judicial innovations.
- Undertaking trainings,
- **Etc.**



#### **EMERGING ISSUES DURING THE YEAR 2023**

On the side of court users I receive many complaints relating to;

- Delayed judgments and rulings
- Alleged bias and refusal to determine recusal applications
- Allegations of corruption
- Absentism, late coming and leaving early from duty.
- Substandard judgments and rulings.
- Lack of customer care

- Some Judges do not have sound vehicles.

- f) Establishing special procedures to fast track SGBV cases.
- g) Enhancement of jurisdiction of Magistrates to reduce on cases that go directly to High Court.

# PERFORMANCE TRENDS OF THE MAGISTRATES' COURTS IN THE LAST THREE (3) YEARS -2021,2022,2023

#### **Caseload Profile**

Magistrate Courts recorded a marked reduction in Case Disposal in the year 2023 as compared to the year 2021 and 2022. On the other hand, the Magistrates' Courts experience steady growth in case registration over the three (3) -year period under review.

- Summary of Individual Ranks of Magistrates for the Calendar Year 2023
- Table 1 below provides the Case Performance for Individual Ranks of Magistrates for the Calendar 2023;
- The Magistrates Grade I completed the highest number of Cases (133,191 cases) followed by Chief Magistrates (36,190cases).
- The Magistrates Grade II completed the lowest number of cases (7,225).
- The performance is strongly correlated with the staffing levels at the respective Individual Ranks, with Magistrates Grade I having the highest staffing (270 Judicial Officers) followed by Chief Magistrates (82 Judicial Officers), and Magistrates Grade II having the lowest staffing (18 Judicial Officers) as at 31st December 2022.
