The Defendant agreed that the balance of Uganda Shillings Two Million Eight Hundred Twenty One Thousand Nine Hundred (UGX 2,821,900) could be paid later after the Plaintiff's flight and specifically not later than 4 weeks from the departure. d) That the Defendant acknowledged receipt of the said payment and subsequently issued the Plaintiff with what purported to be an airline ticket. e) That on the 4th of April 2025, the Plaintiff presented himself at Entebbe International Airport for travel, but was informed that the ticket was a dummy ticket and that there was no valid booking under his name with Ethiopian Airlines. f) That as a result, the Plaintiff missed his scheduled travel, and the bookings he had made for tour guides, transportation, and accommodation in Jakarta were rendered useless and non-refundable, causing him loss and inconvenience. g) That the Plaintiff informed the Defendant of the incident, but the Defendant failed to take responsibility and insisted that the ticket was genuine.
