- 9:40a.m Law Officers led by the Attorney General, the Solicitor General, Director of Public Prosecutions, Administrator General, Registrar General, Senior Counsel and Advocates assemble, robed, on the tarmac at the High Court.
- 9:45a.m Invited Guests, including Ministers, Diplomats and Religious Leaders, arrive at the High Court and immediately take their seats.
- 9:50a.m The Hon. Principal Judge, Justices of the Supreme Court, Justices of Court of Appeal and Judges of the High Court assemble, robed, at the High Court.
