INTRODUCTION:

- i. The paper is intended to give a highlight of the progress to date with regard to the proposed improvement of the Terms & Conditions of Service of the Judiciary staff.
- ii. I wish to point out that the prime mover of all the reforms/ changes the Judiciary would wish to achieve is in ensuring that the Administration of Justice Bill is passed into law.
- iii. All these proposals will be achieved naturally under a defined legal frame work.

Nevertheless, I wish to inform the Hon. Members that after some consultations, the proposals have been presented to the Hon. Minister of Justice and Constitutional Affairs who has promised to follow them up with the Ministry of Finance. I take the honour to quickly reflect on them:

OBJECTIVES OF THE PROPOSED IMPROVEMENT

Over all Objective

In order to enable the Judiciary perform its functions independently, there is urgent need to improve on the terms & conditions of service of the Judges & other Judicial Officers including non Judicial staff.

Specific Objectives:

- Society's expectations of the judges & judicial officers are high & so they should be able to afford & attain those standards.
- Impartiality requires a reasonable level of economic independence.
- Judges & judicial officers work full time & unlike other public servants, they are prohibited from or restricted from engaging in private business even on part time basis.

.....Specific Objectives:

- 4. Judges & judicial officers face very high risks in their daily lives dealing as they deal with hardcore criminals and sensitive cases. They therefore need to be financially insulated from these risks.
- Judges & Judicial officers are not expected to enter into credit transactions which may compromise their independence.
- 6. Non Judicial Officers play a complimentary role in the administration of Justice & therefore should be considered in the same vain.

.....Specific Objectives:

- 7. Lawyers from whom Judges & other Judicial Officers are appointed earn considerably higher incomes than persons working in other sectors of society. It is therefore important that the Judges & Judicial officers earn such salaries which attract lawyers from private practice & other sectors to join the bench.
- 8. Improvement in the terms & conditions of service will reduce on brain drain due to search for greener pastures elsewhere.

.....Specific Objectives:

9. Inflation has rendered the present rates of remuneration insufficient and un realistic. It is desirable that the remuneration should be reviewed from time to time.

SALARY ENHANCEMENT AND ITS EFFECT ON COMPUTATION OF JUDGES BENEFITS.

Last year H.E. the President recommended to the 2nd Deputy Prime Minister and Ministry of Public Service that Justices and Judges can retire with full benefits. This has not yet been implemented. However, the MOPS has prepared a Cabinet Paper on the subject matter and the paper is due for presentation to Cabinet. We await the Cabinet resolution on the matter.

.... Salary Enhancement

There is a proposal that all Justices, Judges, Judicial and Non Judicial Officers remuneration be enhanced to motivate them for better performance.

To support this enhancement a study was undertaken to compare the emoluments and other benefits of Judges in other Countries against what the Ugandan Judges receive.

COMPARISON WITH OTHER COUNTRIES

A Study:

- was carried out in some of the countries in the Eastern & South African region which included Tanzania, Kenya, Zambia, Zimbabwe, Botswana, Malawi & South Africa.
- Further comparison was made with developed countries like Britain.
- Statistics of the other East African Countries compared to Uganda according to this study is given below.

Therefore, the proposed recommendations made here had in consideration of what is obtaining elsewhere

SUPPORT STAFF(Non Judicial Officers)

There is a category of staff that work in the Judiciary but are not judicial officers. This category offers an invaluable administrative support function for the smooth delivery of the administration of justice. They actually form the bulk of staff of the Judiciary. They include Secretaries, Court Clerks, Interpreters, Records and Accounts staff as well as Senior Administrators.

- Housing allowance in lieu at the rate of 80% of the salary
- 2. Transport allowance at the rate of 80% of salary
