
Justices

- One (1) Justice was appointed to the Court of Appeal/Constitutional Court making the current number of the Justices of Appeal/Constitutional Court thirteen (13).





- Mandatory fast-tracking of the Election Petition Appeals and Applications



Criminal Appeals categorized by offences







Registration of Mediations for the period Jan - Dec 2023 vs. 2022




Registered cases in the Court of Appeal for the Year 2023 compared to 2022
