Role players/stakeholders

- Judges—different levels.
- Judges and Jury
- Hybrid system e.g. Military Tribunals/Courts Martials (Judge Advocates, guiding on legal matters, lay persons (Members of Courts) sentencing.
- Local Council Courts members
- Society/family members (e.g. in family courts)

Factors that influence sentencing

- The law.
- Training background/lack of training on the law relative to sentencing.
- Courtroom environment.
- Ideology—prevailing state paradigm— National interest, politics.
- Societal considerations—prevalence of crime in society—deterrence theory e.g. human sacrificing.
- Retribution—why did he or she act criminally judge's temperament.
- Cultural relativism.

Factors that influence sentencing cont.

- The convict—his or her mental status, age, remorsefulness e.t.c.
- Human rights thinking/paradigm e.g. death penalty.
- International relations e.g. death penalty
- Gender considerations:—
 - Wife
 - Husband
 - expectant mother
 - Breadwinner
 - orphan,.....

Italian court rules food theft 'not a crime' if hungry 3 May 2016



The court found that the homeless man was acting 'in a state of need' so his actions could not be considered offence.

Ignored during the sentencing stage!!!

'These laws forced judges to look at their calculators instead of into the eyes of the defendants they were sentencing.

Conclusion

- Sentencing is a legal process—Judges should not lose focus of the law.
- It is, however, not a preserve of trained judges.
- Various stakeholders have a role to play in sentencing.
- Various factors are taken into account in sentencing a convict.

Recommendation

- Professional Judges must be mindful of the law while considering the sentence to impose on a convict.
- They should, however, in particular circumstances, be helped by other stakeholders e.g. psychiatrists, to arrive at a suitable sentence for a convict.
- Non-professionals who are legally empowered to impose sentences should be given preliminary training on the purpose of sentences.
