(A copy of the Defendant's response is attached and marked "P2")</p> <p>(e) On 27th February 2021, the Plaintiff wrote to the Defendant clarifying that the land belongs to the Plaintiff and also proposed a joint boundary opening exercise on 11th March 2021 at the said land to resolve the encroachment issue. (A copy of the letter dated 27th February 2021 is attached and marked "P3".)</p> <p>(f) However, the Defendant declined to participate in the joint boundary opening exercise.</p> <p>(g) Due to the Defendant's refusal to participate in the joint survey and boundary opening exercise, on 20th April 2021 the Plaintiff through their lawyers ALP Advocates wrote to the Defendant informing them that the exercise would be conducted in their absence.
